5. ARCHITECTS REPORT

Bruce states a couple of weeks ago we achieved the first major milestone that the F wing (blue wing) was completed and open for students and staff. This is the first group to get into their new wing. Congratulations to everyone. Moving forward we are now focused on the next classroom wing and a series of other areas which will then be opened in August/September in time for school to start. We still have the furniture that will get delivered and the technology equipment for those various pieces. Architecturally we are continuing with daily conversations with Gilbane. If there are questions and assisting them in facilitating getting this project constructed to meet the expectations of Enfield. It's pretty exciting and I think there's going to be a lot of work you're going to see between now and August.

6. CMR REPORT

Marcus begins a Powerpoint presentation. Shows picture of exterior of the auditorium addition, the future entrance into the lobby corridor. Shown is the substrate panel that goes on before the finished cement board siding. Another air vapor barrier goes on the cement board siding so over the next month or so that process will be completed. The next picture inside is standing on the stage at the black wing entrance. You can see the duct work done. They're finishing the sprinkler pipes. You can see the proscenium wall with the stud framing above the beam. The next picture is looking at the tiered seating section. All the framing in a ceiling area will be a draw two drywall clouds in the back of the auditorium. Those are completely framed at this point. We will start roughing the MEP's into them and getting them sheetrock over the next month. Next picture is standing on the stage looking out over the auditorium. We are starting the process of framing. There's 3 more clouds in the front of the auditorium that are made out of a wood finish that we're going to get framed similar to an acoustical ceiling. They get locked in grid type of wood paneling. Area B/C locker room picture shown. We have the new locker rooms. Over the last month we've been working on finishing the overhead MEP's. We've poured the bases that the lockers will sit on. In the next month we will be putting in the drywall ceilings in that area and working toward getting ready for lockers towards the end of April. A picture of the future school store opening/ticket booth for when you come to the auditorium. This same picture is the entrance to the auditorium. Stud framing is slightly up the hallway. In that opening in that atrium area that will be the display cases. There are a couple of those throughout that area. We're working through getting the electrical and technology roughed in so we can sheet rock that area in about a month's time. Area B (black wing) picture shows the flooring starting to put

down the corridor flooring working from the hub on their way out. On the right you see the majority of the classrooms in this wing with ceiling drip up, some MEP fixtures already roughed into that grid, millwork in place or in progress of going in place and flooring down and protected so that area is well into finishes at this point and is tracking very well to be ready for next school year. Next photo of area C (Yellow) these pictures are under the fitness area, which sits in the old girls locker room. There are new storefronts. On the inside we are in the process of taping the drywall. We have a rooftop unit that we're landing this week that supplies fresh air to that area and then we will be able to finish the ceiling and get it painted. Area C (Yellow) Cafeteria, these are pictures of the future cafeteria. We just started sheetrock in this area this week. Overhead MEP rough is substantially complete with the exception of tying in some of the DAV fan coil units from a piping standpoint. The right picture is standing at the hallway between the old pool and the cafeteria. Area G (White), our new area, we finished area F and we've now taking over Area G. Picture shown is area as it is today, with ceilings down, flooring removed, windows removed. The balance of the clean demo on that 2nd floor is going to take place over the next week and a half. Picture of a typical classroom in area G shown. All the ceilings are gone and most of the marker boards are down. Floors are out and we are pretty well through asbestos on the majority of the wing. We have some baseboards to take out and some demolition in the bathrooms. As a reminder the left picture shows the bathrooms. The tile walls on the outboard side of both of the gang bathrooms stay. We paint those but we tear down basically the entire rest of the bathroom groups and rebuild them exactly the same as what we did in the area F. This April we also take over the gymnasium with the intent to finish it by the end of summer/early fall which we're working with the school to finalize. That is the next big phasing change that will happen on our end.

Walter states when you were showing the white wing, the little picture with the arrow in the corner is the blue wing. Also, can you forward this to me so I can show at the Board of Ed meeting?

Andrew asks for one as well.

Samantha states we officially moved out of white wing and into blue wing. The students are in there and so far everything has been good. We're going to keep coordinating with the school and Gilbane in terms of moving items.
