

Payment Plans for Camp Tons-O-Fun

Payment plans are now available for Camp Tons-O-Fun! These plans are perfect for every budget. Signing up is quick and easy, and your payments can be automatically deducted from your credit card. There are no interest fees or other extra charges when you use our payment plan. What could be better?

PAYMENT PLAN OPTIONS

OPTION ONE –REGISTERING ONLINE

You can register online via *Activenet* on the Recreation Homepage. Credit card payments are automatically deducted. When registering, you must make an initial payment of 25% of your total cost. After that, 2 additional payments will be charged to your credit card. The payment plan schedule is as follows:

- 1st payment - 25% due when you register.
- 2nd payment - half of the remaining balance on **Wednesday, April 17, 2019.**
- 3rd payment - the remaining balance on **Wednesday, May 15, 2019.**

Register Early! Take advantage of our Summer Camp payment plan and spread your payments out. Please keep in mind, our payment due dates will not be changed. Customers who register after each of the payment due dates above must make the 25% initial payment, plus all payments due through the date they register. You must enroll in the payment plan option at the time of registration. Be sure to select the ***use payment plan*** option on the fees page when registering.

If your credit card charges are declined, you will be ineligible to use the Camp Payment Plan for the remaining payments. The outstanding payment(s) must then be made in full via cash or check in the Recreation Office within three business days or your child will be removed from the remaining weeks of camp. Your initial registration payment (25%) will not be refunded.

OPTION TWO –REGISTERING IN PERSON

You can register at the Recreation office during regular office hours and set up a payment plan. These payments will be made via cash or check. When registering, you must make an initial payment of 25% of your total cost. A customized payment schedule will be set up with you at the time of registration. All payments must be made in full by **Wednesday, May 15, 2019 at 4 PM.**

Installments must be received by the payment plan scheduled due dates. Failure to make payments according to the payment plan schedule may result in the participant(s) being withdrawn from the program, and your initial registration payment (25%) will not be refunded. A grace period of three business days will be granted on late payments.
