COVID-19 UPDATE RELATED TO OUR TRADITIONAL SUMMER CAMP PROGRAM

Since the start of the COVID-19 pandemic, the Enfield Recreation Division has remained committed to providing essential services to Enfield families. Our team has been adhering to federal, state, and local guidelines pertaining to all programs and services. Aligned with guidance from the Connecticut Office of Early Childhood (OEC) and the North Central District Health Department (NCDHD), our division is pleased to announce that we will be offering a *modified* summer camp again this summer, **beginning June 28, 2021.**

REGISTRATION INFORMATION

Registration for Summer Care is limited and is offered on a first come, first serve basis. Registrations will not be accepted before the registration start date. The Recreation Division will accept online, mail-in and in-person registrations. Phone registrations are not accepted. Payment is due upon registration. Payment plans are available. Don't delay, spaces are limited and fill quickly!

SUMMER CARE IS HELD AT THE ENFIELD ANNEX LOCATED AT 124 NORTH MAPLE STREET.

GRADES: Summer Care is for children entering grades 1 through 9 in September 2021. Participants will be broken up into groups based on age.

DATES: The program operates from Monday, June 28th through Friday, August 13th. **No program on July 5th.**

TIME: Participants should arrive at 8:00 AM and be picked up at 4:00 PM. Please make sure you are on time. Late fees will be assessed for those picked up late.

PAYMENT: Acceptable forms of payment include: cash, check, money order or credit card (***online registration only***). Registrations are accepted online, by mail or in person at the Recreation Office during business hours, Monday - Friday, 8 AM - 4 PM.

Registration begins: Friday, March 26th at 8:00AM

NOTICE: Due to the everchanging nature of the pandemic, the Recreation Division reserves the right to adjust programs and services as deemed necessary to ensure the health and safety of all participants and staff.

Program Changes and Safety Modifications due to COVID-19

Following the guidelines from the OEC and local health officials, our summer camp will look different than in years past, but as always, we are committed to ensuring the program is safe and fun for all participants. Because summer camp is an essential service for families returning to work, we are changing our camp name to *Tons-O-Fun Camp Summer Care*. **This is due to restrictions surrounding our ability to offer field trips, guest entertainment and daily visits to the pool.**

Program Details

- ◆ Summer Care will be available for campers entering grades 1 – 9 in September 2021. The program will run Monday – Friday, June 28 – August 13 (*no 7/5*), in one-week sessions.
- ◆ Hours of operation will be modified to 8:00 AM – 4:00 PM. No additional before/aftercare will be offered.
- ◆ Summer Care will not include any field trips. Pool time will be dependent on further guidance from the State of Connecticut and staffing availability.

Safety Protocols and Modifications

Our team is developing comprehensive safety protocols and modifications in conjunction with the OEC and NCDHD to ensure our Summer Care program is as safe as possible. Some of those changes include:

- ◆ Capping group sizes to 20 campers with 2 staff members and keeping participants exclusively to these groups throughout the week.
- ◆ **Requiring all participants and staff to wear a mask.**
- ◆ Increased staffing levels to enhance safety measures and supervision.
- ◆ In order to provide the safest care possible, our division has invested in additional staff, personal protective equipment, hand sanitizer, thermometers and more.
- ◆ Drop-off and pick-up will be handled curbside and will require a COVID pre-screen daily for both participants and staff prior to either being admitted to the site.

Additional details will be made available in the coming weeks concerning site specific policies and protocols which will differ from our already established Tons-O-Fun Handbook. - ⇒ Weekly program information will only be sent via EMAIL. Paper mailings will no longer be sent.
- ⇒ Participants will receive their group assignments via email the Friday before their registered week. This will indicate their curbside drop-off location.
- ⇒ Participants with special needs must submit an intake form when registering. This is especially important for children who have a one-on-one during the school year.
- ⇒ Participants who require medicine administration must have completed paperwork on file five business days before the session start date.

If you provided us with your email address, you will receive an electronic confirmation that your registration has been processed. If not, please include a self-addressed stamped envelope so we can mail you a receipt. Please contact the office if you do not receive registration confirmation within 10 days.

To be processed, registrations must include a completed registration form, proof of residency, and payment in full. Incomplete registrations cannot be processed.

If you have any questions about Summer Care, please contact the Recreation Division BEFORE you register your child. Refunds are only given for medical reason on receipt of a doctors note. Please see Withdrawal Policy on the website for complete information.
